

APPLICATION FOR MEMBERSHIP

1. General

- a. The application should be completed in full and must be accompanied by the following documents as appropriate.
- b. Any false declarations, whether on the part of the applicant or the proposer(s), may lead to disciplinary and/or legal action.
- c. The Association is not bound to give any reason for their refusal to admit any person to membership, or to transfer a person from one class of membership to another. Any applicant who is refused admission shall not be legible to reapply within twelve calendar months from the date the application of rejection.
- d. Applications which do not meet the full requirements of the by-laws of the Association will not be considered. The Association reserve the right not to consider any applications should the required information is not disclosed by the applicant.

2. Qualifications for various Classes of Membership

- a. Application for the class of Corporate Member shall be a company registered Hong Kong. Please provide a copy of your Business Registration certificate for verification.
- b. Application for the class of Individual Member shall be person over 18 years of age resident in Hong Kong. Please provide a copy of your Hong Kong ID card for verification.
- c. Application for the class of International / Affiliate Member shall be a person interested in the objectives of the Association who is not completely qualified to be a full member.
- d. Application for the class of Student Member shall be person over an individual under 30 years of age, and be a student in a college or university preferably of technical discipline. Please provide a copy of your student card for verification.

3. Annual Membership Fee

- a. All applications must be accompanied with the annual membership fee. The HAESCO Annual membership fee paid is not refundable, except in the event your application is refused.
- b. All Fees subject to change.

- d. Your membership fee will cover a twelve consecutive month period from 1 April thorough to the following 31 March. If a member joins during the HAESCO year:
 - i. When a member joins the Association between 1st September and 31st December inclusive, the member shall pay 50% of the appropriate annual fee for the remaining membership year.
 - ii. When a member joins the Association after 01 January, the member shall pay the full membership fee, but will enjoy membership commencing from application date thorough to following 31st March (up to a maximum of 15 months).
 - iii. The membership fee for subsequent years will resume normal upon renewal.
- e. Application for membership must be supported by at least two proposers being members of the Association.
- f. Any member shall be liable to pay the annual membership fee for the ensuing year upon admission into membership and upon expiry of the annual membership fee for the current year.
